Dear Secretary Salcedo,

I'm writing to express our appreciation for the Government of Mexico's participation in the Open Government Partnership (OGP), a global initiative encompassing 76 countries and 106 local governments dedicated to advancing transparency, accountability and citizen engagement in policy making.

Central to participation in OGP is the co-creation of an action plan by each member government, outlining specific open government reforms consistent with OGP Participation and Co-Creation standards.

Regrettably, the OGP Support Unit did not receive an action plan from the Government of Mexico by the 31 December 2023 deadline. Consequently, the Government of Mexico has acted contrary to the OGP process for the 2023-2025 cycle.

This marks the second consecutive cycle in which the Government of Mexico has acted contrary to the OGP process. Enclosed, please find a copy of the notification letter concerning the previous occurrence (failure to deliver an action plan in 2022). In accordance with OGP policy, Mexico has been placed under "Procedural Review" by the Criteria & Standards Subcommittee (C&S). This review process entails enhanced support from the OGP Support Unit and the Steering Committee to address the underlying issues leading to the review.

The Procedural Review can be resolved by submitting an OGP action plan by the upcoming deadline of 31 December 2024. Should this deadline not be met, the Government of Mexico would be found noncompliant with the OGP process for a third consecutive cycle. Any country failing to deliver an action plan for three consecutive years will be recommended by the C&S Subcommittee to be designated as "inactive" within OGP.

To avert the risk of such designation and to resolve the Procedural Review, the Government of Mexico must submit a new action plan by 31 December 2024.

Please be assured of our unwavering commitment to assisting you in the co-creation of your next action plan, ensuring full compliance with all requirements.

Dear Secretary Salcedo,

We welcome the Government of Mexico's participation in the Open Government Partnership (OGP), which now comprises 76 countries and 106 local governments working to implement open government commitments to promote greater transparency, accountability and citizen engagement in policy-making.

As you are aware, all OGP participating governments are expected to co-create an Action Plan outlining a concrete set of open government reforms, in line with OGP Participation and Co-Creation standards.

As of December 31, 2022, the OGP Support Unit has not received a new action plan from the government of Mexico. Therefore, Mexico has acted contrary to the OGP process for the 2022-2024 cycle. The government of Mexico is also now considered to have started a new action plan cycle. Mexico's new action plan must be delivered by 31 December 2023.

Failure to meet this deadline would result in Mexico acting contrary to OGP process for a second consecutive cycle, and therefore would be placed under Procedural Review by the Criteria & Standards Subcommittee.

The OGP Support Unit and Steering Committee stand ready to support you during the implementation of your current action plan and the development of your next one to make sure all requirements are met.
