Representing the illustrious Municipality of San Joaquin, I am pleased to express our interest in joining the Open Government Partnership Local. As a demonstration of our commitment, we endorse and uphold the principles set forth in the Open Government Declaration, considering it a duty to "foster a global culture of open government that empowers and serves citizens and promotes the ideals of open and participatory government in the 21st century."

San Joaquín is a commune located in the southern sector of the city of Santiago, capital of Chile. Currently, it has an approximate population of 103,000 people, with 11.8% of them having an income below the poverty line. Our commune is characterized by high citizen participation, with 85 Neighborhood Boards, 96 Security Committees, and a network of entrepreneurs that brings together more than 700 individuals. Additionally, we have collegial bodies in each Health Center, enabling direct dialogue with users.

Our administration took office in June 2021, immediately embracing a commitment to citizen participation and public integrity. We conducted the first municipal audit in 28 years and signed a collaboration agreement with the General Comptroller of the Republic, the Undersecretariat of Regional Development (SUBDERE), the Civil Service, and the United Nations Development Programme (UNDP). Through this agreement, we developed and implemented our first code of ethics, a fundamental tool for strengthening probity and transparency. We also enhanced participation mechanisms, activating the Civil Society Council (COSOC) of San Joaquín, conducting binding citizen consultations, "Government in Your Neighborhood" operations, and taking the Municipal Council to the territories. Further details on these and other initiatives are available in our "Diagnosis of Good Municipal Practices in Open Government."

For 2023, our goal is to progress towards an open municipality with the support of digital tools. The Municipal Council, a normative, decision-making, and oversight collegial entity, approved an Action Plan aimed at collaboratively designing a participation and transparency policy with the residents of our territory. This emphasizes the importance of preventing situations of ethical non-compliance in public institutions and making data available to the public. This led to the creation of the San Joaquín Community Open Government program, under the Municipal Administration unit, with a dedicated Open Government Coordinator and a budget for hiring professionals and operational expenses. Support is also provided by municipal units, especially the Departments of Community Development, Local Economic Development, Community Security, and the departments of Health, Communications, and Information Technology, including their personnel and technical resources.

In this way, we co-created the first Open Government Plan of San Joaquín, a process that began in August. The COSOC, a representative space for various community organizations, chose to work on the themes of women and entrepreneurship, health, and security. Together with representatives from neighborhood boards, security committees, health councils, women entrepreneurs, and various municipal units, we gathered information that allowed us to generate preliminary proposals. These proposals were then subject to a vote through the "Commitments for an Open Municipality" Citizen Consultation held in December, in which nearly 1,000 residents participated. Throughout the process, we maintained contact with the Economic Commission for Latin America and the Caribbean (ECLAC), Tribu Foundation, and other municipalities in the country that are already part of OGP Local, such as Maipú and Peñalolén, from whom we received specific supports.

The prioritized proposals that make up our first action plan and will be implemented during 2024 are:

- Promote the primary health network
- Promote community security
- Promote the well-being of women


In addition to the above, in line with our commitment to transparency and accountability, in collaboration with community organizations, decided to develop proactive transparency platforms called "Transparent Budget" and "Online Program." The first will provide updated and easily understandable information to the public about the budget execution of the Municipality, categorized by work areas. On the other hand, the second initiative will account for programmatic execution based on what was proposed during the electoral campaign, demonstrating coherence in municipal management and the fulfillment of commitments made to the residents of San Joaquín.

With the commitment to continue advancing in citizen participation, accountability, and transparency, involving the community more in municipal management, we believe it is crucial to be part of OGP Local. Being part of this international network involves joining forces with other government agencies and civil society organizations to transform how public management interacts with citizens and share lessons learned about the results obtained.

On our part, we make available the knowledge gained during the co-creation process of our first Open Government Plan, particularly in the prioritized themes (Security, Health, Women, and Entrepreneurship), and in the platforms developed for the citizen consultation and proactive transparency.

San Joaquín is the fourth commune in the country to co-create its open government plan, which will be implemented in 2024. It is a challenge for our local administration to achieve results that impact residents, and we hope to have your support and collaboration, along with that of other municipalities part of OGP Local with whom we can share lessons, methodologies, and challenges, as we understand that the prioritized themes are common among other local governments. Additionally, we see joining OGP Local as an opportunity to continue developing open government plans in the future, establishing it as a sustainable practice over time, evaluating them with proper guidance, and making improvements in both execution and co-creation.
