Government Letter of Support. Call for new members to OGP Local 2024

I am honored to confirm the interest of the Souss-Massa Region to apply to join the local program of the Open Government Partnership. This is based on a formal decision of our Regional Council during its extraordinary session held on November 16, 2023.

This application falls within the Council framework to strengthen mechanisms of Openness, Participatory Democracy, and Citizen Participation, as well as our commitment to strengthen the principles of Good Governance in the management of public affairs and the



respect of the Universal Declaration of Human Rights. We fully endorse the Open Government Declaration and its principles.

This initiative comes in a particular national context where the Kingdom of Morocco is witnessing a growing dynamism, especially after the adoption of the 2011 Constitution, which established a new momentum around raising the level of citizen participation and the right of citizens and NGOs to Contribute to decision-making in public policies, both at the national and the local level.

The Moroccan roadmap of advanced regionalization seeks to confront the development challenges by strengthening decentralized governance and participatory democracy through establishing an action framework based on good governance, transparency and participation. A similar approach was adopted to shape the new development model that emphasizes the importance of citizens and civil society mobilization in public affairs management.

Additionally, the Souss-Massa Region is promoting Openness, Participation and Inclusion, relying on a Participatory and Consultative Approach in preparing planning documents that embody the strategic



development vision through the regional design for territorial preparation and the regional development program (2022-2027). This is done via:

- An online space on the official website to receive the opinions of citizens and associations related to the Regional Development Program;
- Three consultative bodies created by adopting objective criteria in the selection process, taking into account the principles of transparency, equal opportunities, merit, and geographical justice. Since its launch, the consultative bodies have shown engagement in distinguished practical initiatives;
- Promoting Access to Information Through Various Channels.

It is worth noting that the Souss-Massa Region is at the forefront nationally in terms of the density and diversity of civil society organizations. And the region has leveraged the rich experience of civil society in various initiatives, including:

- Launching a digital consultation process with civil society in order to strengthen and enhance institutional communication. This was done in partnership with the General Directorate of Territorial Communities, the Association of Moroccan Regions, and the British Embassy in Rabat, to support the participation of citizens in territorial decision-making;



- Launching the digital consultation process around the sustainable development goals in the Souss-Massa region by the three advisory bodies within the framework of the project to support reaching the sustainable development plan, Agenda 2030, in partnership with the Ministry of Energy Transition and Energy Efficiency and the International Cooperation Agency.

In the same spirit, the Souss-Massa Region has been a member of the Moroccan Network of Open Territorial Communities (REMACTO) since its establishment in October 2022, which is considered a national space for dialogue and the exchange of experiences in order to perpetuate the principles of Open Government.

In the context of preparing the application for candidacy to join the local program of the Open Government Partnership, we were keen to adopt a participatory approach with the actors in this framework (the advisory bodies established in the regional council) through:

- Organizing a meeting at the regional council to build a roadmap to promote Open Government at the local level by engaging members of the advisory bodies. This was done with the support



of the General Directorate of Territorial Communities and the Association Impact for Development;

- Identifying priority themes for Open Government in partnership with the three advisory bodies;
- Assigning a mixed committee to follow the preparation, implementation and evaluation of the action plan of Open Government in the region;
- Organizing an in-person workshop for the cocreation of the Open Government Action Plan for the region, with the participation of members of the three advisory bodies created by the Souss-Massa Region Council. Ideas and proposals were submitted in the different priority themes of the region;
- Signing a memorandum of understanding with the National Democratic Institute to support the region's efforts in the co-creation phase by strengthening the capabilities of the elected officials and employees of the Souss-Massa region and members of the advisory bodies of the council, as well as in order to exchange experiences and technical support;



- Presenting the draft Action Plan of the region for public consultation through the website of the Moroccan Network of Open Territorial Communities during the period from 18 to 23 July 2023 in order to include all citizens and civil society in the participation process;
- Organizing a second in-person participatory workshop with the participation of the advisory bodies, where all proposals were studied and a final plan was co-formulated;
- Presenting the program to the permanent committees of the Council.

This dynamic participatory process has produced an important action plan that covers the following axes:

- 1- Participatory democracy;
- 2- Inclusiveness and territorial justice;
- 3 - Gender equality;
- 4 - Sustainable development;
- 5 - Economic development;
- 6- Budget transparency.



Based on what was mentioned above, we hope that our request to join the OGP Local program would be accepted to enable us to share our experiences and efforts and benefit from the experiences of other local governments in the world.

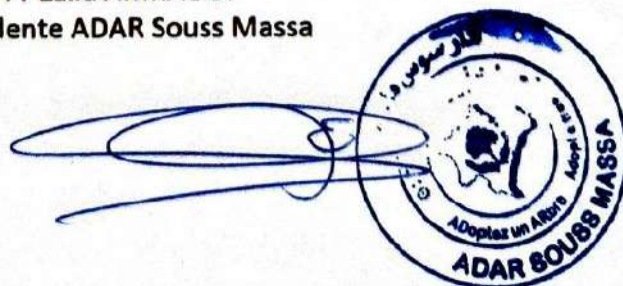


