APPLICATION TO JOIN THE SUB-NATIONAL GOVERNMENT PROGRAM OF THE OPEN GOVERNMENT PARTNERSHIP

The Tamale Metropolitan Assembly intends to declare its commitment to joining the Sub-National Program of the Open Government Partnership (OGP). The Assembly is one of the Six Metropolitan Assemblies in Ghana and the capital City of the Northern Region of Ghana with a population of 409,216 people. The Assembly was established by a legislative Instrument (L I 2068) after the carving out of the Sagnarigu Municipal Assembly in 2012.

The Assembly is the highest political and Administrative Authority in its areas of jurisdiction and mandated by the Local Governance Act, (Act 936) of 2016 to ensure the Overall Development of the under its jurisdiction. The Assembly achieves this mandate by planning and executing development programs meant to improve the living standards of its people.

Chapter 20 of the Constitution of Ghana, Article 240-2(e) states that "to ensure accountability of Local Government Authorities, people in particular Local Government Areas shall as far as practicable be afforded the opportunity to participate effectively in their governance" In the same vein, the Local Governance Act, 936 has mandated Assemblies in Ghana to involve the citizens in their activities to achieve inclusive governance founded on transparency, probity and accountability.

It is in the fulfilment of the above mandate that the Assembly is constrained for which reason we intend the join the Open Government Partnership. Our Planning and Budgeting Process is not participatory enough to achieve the much needed transparent and accountable governance. Our Budgeting and Fee Fixing Process leaves out the required Citizen participation and the Functional Relationship between the Assembly Members and the General Public is weak.

It is for the above reasons that we wish to join the Open Government Partnership to tap into the wealth of knowledge and experience of other partners to develop a comprehensive action plan to address the issues of participation, transparency and accountability in the delivery of our services.

Recognizing the strategic objective of the open Government Partnership which is based on the idea that governments should be more transparent, inclusive, participatory and accountable to citizens and the object of governance is to address the needs of the people in a more efficient manner, the Tamale
