We are committed to advancing in key areas such as social inclusion, environmental

sustainability, and the digitalization of services. These themes are integral to our

Municipal Strategic Plan 2023-2027, through which we aim to implement policies that

foster citizen trust and improve the quality of life for the residents of Curridabat.

Curridabat has been part of the OGP alliance since 2020 and has established an ad hoc

Institutional Commission and a Political Commission within the Municipal Council to

coordinate efforts to drive open government initiatives. The Municipality of Curridabat

has taken significant steps to institutionalize active listening and direct communication

with organized communities, primarily through the Peace Culture Office and the

Human Development Centers, which systematize citizen demands to address them

through listening and participation. For Curridabat, the systematization of citizen

demands is at the heart of planning, allowing action based on science, data, and real-

life experiences rather than political events.

**Achievements in Open Government** 

Since 2012, Curridabat has established Human Development Centers that bring socio-

educational services closer to communities to overcome structural barriers. We have

also developed a Cantonal Art and Culture Policy through a participatory design

process and have implemented public infrastructure projects based on nature-based

solutions, such as flood mitigation and traffic calming initiatives. Although the "Yo

Alcalde" app is currently in a pre-launch phase with an expected release in February

2025, it has become a critical tool for managing citizen demands and has benefited from citizen input and accessibility enhancements recommended by external stakeholders.

#### **Challenges and Strategic Vision of Open Government**

In our Municipal Strategic Plan, open government principles are essential in core experiences, such as quality relationships, trust in the environment, access to desired destinations, connection with nature, and soil regeneration. Each experience aims to bring municipal services closer to individuals, living beings, and planetary systems, enhancing the performance of ecosystem services and life satisfaction.

# Some Challenges Include:

- Structuring human development services through active communication under the new concept of "Curridabat Communicates."
- Continuous communication campaigns on topics such as water balance and soil regeneration.

#### **Medium-Term Goals**

The medium-term goals derived from our open government practices include creating management bridges between citizens and local government, implementing a Strategic Experiences Atlas, and conducting citizen satisfaction surveys to assess municipal services. These objectives contribute to our Open Government Strategic Vision, enhancing management opportunities and data-driven decision-making.

### **Commitment to Coordination and Oversight of the OGP Action Plan**

The Municipality of Curridabat is committed to coordinating efforts between government agencies and civil society to implement the OGP action plan. This plan involves structured working groups, citizen assessments, and digital open-data platforms to share results and ensure transparency in achieved progress.

We firmly believe that our continued participation in OGP Local will drive the cultural transformation of Curridabat in areas of transparency, accountability, access to information, and citizen science, contributing to building a more inclusive Curridabat that upholds open government principles.
