

OPEN STATE COMMITMENTS IN THE AMERICAS

Four judiciaries in the Americas have made six Open Gov Challenge commitments. Explore examples from the Challenge and beyond.

CHALLENGE

Open Justice for an Open State



Chile's Supreme Court and the Public Defender Office <u>committed</u> to improving access to justice through multi-stakeholder initiatives to engage local communities.

CHALLENGE

Transparency and Accountability in the Council of State



Colombia <u>committed</u> to using plain language in judicial decisions for key topics and consulting the public on priority information to release.

CHALLENGE

Strategy to Reduce the Judicial Backlog



Costa Rica's judiciary <u>committed</u> to reducing the backlog by publishing all court case data on a centralized platform. This will allow the public to monitor progress.

CHALLENGE

Open Justice Policy



Honduras <u>committed</u> to publishing judicial information in plain language, training judges and staff, and creating a centralized website with court-related information.

ACTION PLAN

Federal Open State Program



Argentina <u>committed</u> to hosting regional workshops, providing technical assistance to local-led projects, and mapping of relevant actors and initiatives.

ACTION PLAN

Public Participation in Virtual Congress Sessions



Chile <u>committed</u> to developing an Al chatbot to facilitate the public's participation in virtual sessions of its parliament.

ACTION PLAN

Open and Accessible Court Rulings



Colombia committed to publishing Constitutional Court cases in plain language and making key rulings more accessible to ethnic communities.

ACTION PLAN

Plain Language Court Sentences for Vulnerable Groups



Jalisco (Mexico) <u>committed</u> to using plain language in court sentencing decisions for vulnerable groups, such as children, migrants, and people with disabilities.
