



Action Plan of the Global Initiative for Open Government Partnership in Dar Chaaban El-Fehri's Municipality - OGP Local

Introduction:

The global initiative of the Open Government Partnership seeks to promote transparency, civic engagement, anti-corruption, and the use of technology to improve governments. In this context, we commit ourselves to two fundamental undertakings: the first is about Implementing online-mechanisms to increase participation in decision-making, the second is about the Co-creation and implementing a sustainability program with stakeholders.

The first pledge: Implementing online-mechanisms to increase participation in decision-making

Objectives:

1. Increase citizen participation in municipal decision-making through digital tools. In fact, the center that we are renovating is one that aims to transform an old library into a civic solidarity center to develop the creativity and empowerment of vulnerable people including children, youth and rural women and / or residents of poor and marginalized neighborhoods co-created in collaboration between the "action team" and the components of the civil society of the commune of Dar Chaabane Elfehri. We started with the co-creation of the OGP Local action team
2. Improve access to Municipal Information and services via the internet.

Main activities:

1. Work on the creation of a Social Solidarity Center and digital creativity
2. Continue using the El-baladiya online platform. Tn, which allows citizens to participate in public consultations and express their opinions.
3. Regularly update government websites and publish open and accessible data for everyone.

Main indicators:

1. The number of citizens participating in public consultations via the electronic platform.
2. The level of overall satisfaction with the digital services provided.

The second pledge: Co-creation and implementing a sustainability program with stakeholders**Objectives:**

1. Promoting environmental sustainability through open government initiatives.
2. Encourage citizens to adopt environmentally friendly practices.

Main activities:

1. Preparing a municipal program for Sustainable Waste Management in a participatory manner
2. Working on finding mechanisms for valuing stone engraving waste in order to develop the life cycle of the product of Engraving craftsmen and reduce its carbon footprint
3. Continue to work on finding participatory solutions for the good management of rainwater

Main indicators:

1. Achievement progress ratio
2. Number of participants in the program
3. Number of beneficiaries of the program

By adhering to these two pledges, we seek to promote transparency, civic participation, and Environmental Protection, which contributes to achieving the Sustainable Development Goals and improving the quality of life for all citizens.
