Additionally, we have organized the Citizen Transparency Commission, with representatives from civil society.

Citizen Participation:

We recognize that active citizen participation is essential for effective governance. We aim to implement mechanisms that involve citizens in decision-making, ensuring that their opinions and concerns are considered in the development of public policies. To this end, we have the Participative Budget for local allocation, where community leaders, along with the neighbors of each community, determine the projects to be executed, aimed at local development, and incorporated into the Municipal Development Plan, (MDP). We have also organized the Citizen Transparency Commission, with representatives from civil society, the Network of Social Overseers, made up of the prosecutors of each patronage (board) and community leaders, and the Women's Network.

Accountability:

We understand that accountability is a key element to strengthen trust between the municipal administration and the community. We are committed to establishing solid mechanisms to transparently evaluate and communicate the performance of our actions and policies. One way in which we practice this aspect is in the Open town meetings, starting the year with the Open Town Meeting of Accountability, reporting how municipal income and expenses were directed, in addition to reports presented by organizations (NGOs) and institutions that manage public funds, where each representative presents to the people the investment made in the municipality.

Innovation in Open Government:

We are excited about the opportunity to learn from best practices implemented elsewhere through OGP. We seek to incorporate innovations in open government that will improve the efficiency, effectiveness, and inclusiveness of our policies and services provided.
