COMMITMENT TO PARTICIPATE IN THE OPEN GOVERNMENT PARTNERSHIP (OGP) LOCAL PROGRAM

The Nairobi City County government (NCCG) officially joined the Open Government Partnership (OGP) in October 2020 through the defunct Nairobi Metropolitan Services, NMS (Ref: EOP/NMS/20/17 dated 29th September 2020). Following the August 2022 General Elections, a new leadership of NCCG was elected into office, NMS ceased to exist, and all NCCG functions previously transferred to NMS reverted back to NCCG.

The primary focus of the NCCG is to ensure the provision of affordable, accessible, and sustainable quality services while fostering community/public participation and enhancing the well-being of city residents. Our goal is to leverage all available resources, identify opportunities, and adopt an integrated approach to strengthen transparency & accountability, as well as align county policies, programs, and activities to improve the overall welfare and sustainability of our society, people, and ecosystems.


Consequently, the Nairobi City County Government is fully committed to continuing its participation in the OGP local initiative.
